These guidelines represent all levels of Minor hockey and all divisions of Female hockey.

4.8(c)	Game Misconduct	<p>Any player or team official who is assessed a Game Misconduct penalty in the last 10 minutes of regular playing time, at any time in overtime, or after the conclusion of the game will automatically be suspended for a minimum of the next regular league/play-off game or seven days.</p> <p><i>Note: The 1 game suspension under Rule 4.8(c) is in addition to any suspensions applied under the minimum guidelines.</i></p>	1 game
4.9(b)	Gross Misconduct	<p>Any player or team official who is assessed a Gross Misconduct penalty in the last 10 minutes of regular playing time, at any time in overtime, or after the conclusion of the game will automatically be suspended for a minimum of the next regular league/play-off game or seven days.</p> <p><i>Note: The 1 game suspension under Rule 4.9(b) is in addition to any suspensions applied under the minimum guidelines.</i></p>	1 game
